Formalities for Submission (Doctoral Regulations 2017)

A) Application for Admission to the Examination Phase

In the application for admission to the examination phase, the decision on the form of the oral examination procedure chosen in accordance with § 11, the *defensio* or the *rigorosum*, must be stated (cf. § 8 para. 3 no. 6). The application must be submitted together with a written curriculum vitae in table form with a description of the academic career (cf. § 8 para. 3 no. 5).

B) Submission of Reviewer Copies

Design the title page according to the attached sample. The title page has to be printed on the first white page, not on the cover. Please enter the following information on the **back of the title page**: (Names and dates should be added by hand)

Please submit **three copies and an electronic version of your thesis on a standard data carrier** (cf. § 8 para. 3 no. 2) to the Dean's Office for review. **Only** the Dean is responsible for assigning the dissertation to the reviewers.

I declare that I have not utilised any external assistance, in particular paid assistance from mediation or advisory services (doctoral advisors or any other person), for the substantive work on this thesis and that no third parties have received any direct or indirect monetary benefits from me for services related to the content of this thesis.

I agree to the comparison of the thesis with other texts in order to identify similarities and to the storage of the electronic version of the thesis in a database for this purpose.

C) Submission of the Mandatory Copies

In accordance with § 18 (3), the following must be submitted to the Dean's Office free of charge:

Self-publishing ³	23 bound copies in letterpress or photo print
Commercial publisher - Distribution via the book trade and proof of a minimum print run of 150 copies ⁴	9 bound copies
University Publication Service - Number and form of print and electronic versions in consultation with the University Publications Service of the University and State Library of Münster	one electronic version

Changes to the title must be applied for in written form to the faculty board before publication.

All mandatory copies must be recognisable as a dissertation accepted at the University of Münster: In the preface or in another place, the dissertation must always state that it has been accepted as a dissertation by the Faculty of Catholic Theology at the University of Münster (cf. § 18 para. 3d).

At the end of the thesis, the **curriculum vitae with a description of the academic career** and the **signed German affirmation in lieu of an oath** must be included or subsequently glued in.

In accordance with § 19 para. 2, the solemn graduation ceremony can take place at the end of the semester in which the *rigorosa* or *defensio* was completed. The prerequisite for this is that the publication of the dissertation or its inclusion in a scientific series is guaranteed by a written contract between the author and publisher or by a certificate from the editor of a series in which the thesis is to be published. The contract must include a guarantee that the dissertation will be published within two years. In addition, the doctoral candidate must declare in written form that the prescribed number of mandatory copies will be submitted subsequently (cf. § 19 para. 2).

The submission of the mandatory copies or proof of the publication of the dissertation or its electronic publication must be submitted to the Dean's Office within two years after passing the *rigorosum* or *defensio* (cf. § 18 para. 5).
