Information about the mandatory internship in the B. Sc. Psychology programme

In accordance with the requirements of the German Licensing Regulations for Psychotherapists (PsychThApprO) of 4 March 2020, students with the goal of becoming a psychotherapist must complete part of their mandatory internship as an Orientation Internship (150 hours) and part in Professional Qualifying Activity I (240 hours).

The **Orientation Internship** (§ 14 PsychThApprO) is designed to enable the student to gain initial practical experience in general areas related to health and patient care. Students are to be given an initial insight into professional ethical principles and the institutional, legal and structural framework of patient care. In addition, students must be shown the basic structures of interdisciplinary collaboration and structural measures for patient safety. The Orientation Internship takes place in multidisciplinary health care facilities or other facilities that provide counselling, prevention or rehabilitation to maintain, promote and restore mental health.

Professional Qualifying Activity I (§ 15 PsychThApprO) is designed to enable the student to gain initial practical experience in specific areas of psychotherapeutic care. It may only be completed after they have earned 60 ECTS. During Professional Qualifying Activity I, students are to be provided with a basic insight into the institutional, legal and structural framework of psychotherapeutic health care facilities. They must be able to (1) recognise the framework and distribution of tasks in interdisciplinary collaboration and to work together appropriately with the different professional groups according to the distribution of tasks, and (2) to develop and apply basic skills in communication with patients and any other person or professional group involved. Professional Qualifying Activity I can take place in the following facilities or areas, provided that psychotherapists, psychological psychotherapists or child and adolescent psychotherapists work there: (a) facilities for psychotherapeutic, psychiatric, psychosomatic or neuropsychological care; (b) prevention or rehabilitation facilities comparable to the aforementioned facilities; (c) facilities for people with disabilities; or (d) other areas of institutional care.
